Directions from the Trial Site

Turn right onto County Road (approximately 1.3 miles to Rt3 183)

Turn right onto PA-183 South (approximately .5 miles to US222)

Take the ramp onto Us 222 South (approximately 2.9 miles)

Take the exit onto US-222 S/US-422 W toward Lancaster/Lebanon

Continue to follow US-222 South for 3.6 miles

Take the PA-724 exit toward Sinking Spring/Shillington

Then turn right onto PA-724 East – Shillington Road

Continue to follow PA-724 for 1.2 miles

Turn left onto US-222 Business North

Travel .3 miles – Destination will be on the right

Due to Covid restrictions, the building capacity will be limited to 35 people at one time. Limited indoor crating will be available.

Novice, Beginner Novice and Rally will not start prior to 12 noon.

Specific times will be published in the judging schedule.

Masks will be required at all times while in the building. Temperature

checks and signed Covid waivers will also be required to comply with our landlord's specifications. Fill out the Covid Waiver and bring it with you.

Ribbons and cash placement awards will be offered. Class prizes will be awarded outside the ring, not in the ring. Ribbons will be self-serve.

No food will be available on site.

Judges are not required to wait for dogs. It is the responsibility of the owner or handler to have the dog at ringside when its class is called.

Refunds for bitches in season less \$7 per entry with veterinarian's note.

To request an in-season refund, contact the BCDTC Trial Secretary.

All dogs present must be on leash or confined to a crate except when being judged in the ring. Crating space is limited so please be considerate of your fellow exhibitor.

No un-entered dogs permitted inside the trial.

Prizes

A Qualifying Score is required for all prizes in the Regular Classes.

“Dog” means either sex.

A Dark Green Qualifying Score Ribbon will be awarded to all dogs attaining a qualifying score in the Regular Classes.

A Rosette will be given to all dogs completing a new Title.

The Club will not undertake to deliver prizes after the day of the Trial.

Directions to Trial Site:

GPS Address: 1238 County Welfare Road, Leesport, PA 19533

From York/Lancaster – Route 30 East to Route 222 North to Bernville/Strausstown exit. Turn Left onto Route 183 to light at West Leesport Road; make a left through housing development. At stop sign, turn right onto County Road. Travel approximately $\frac{3}{4}$ of a mile and driveway and sign for 4-H Center is on your left.

From NJ Turnpike – To Exit 6 – Pennsylvania Turnpike – to exit 298 (Morgantown) through tolls. Stay Straight to 176 North Connection. Take 176 to 422 West to 222 North (Allentown direction) to Bernville/Strausstown exit. Continue as above.

From New Jersey/Allentown via Routes 22 and 78 – Take exit for 100 S (Trexlerstown). At second traffic light, bear right onto Schantz Road. Travel for 3.5-4 miles to intersection at Route 222 South. Continue south on 222 following signs for Reading and Lancaster. Continue another 1.4 mile past the Route 222 and Route 73 intersection and take the exit for Reading/Lancaster. DO NOT TAKE BUSINESS ROUTE 222. Continue for 4.7 miles exiting at Route 183. Turn right at the end of ramp onto Route 183 for 8/10 mile. Turn left at traffic light at West Leesport Road and continue as above.

Route I-76/PA Turnpike (Exit 298 - Morgantown) – Take Route 176 North to intersection with 422 (approximately ten miles). Continue on 422 West for 4.5 miles. At this point 422 splits with 222 N. Stay in left lane following 222 North for 3.1 miles to Bernville/Strausstown exit. At end of ramp, go left onto Route 183 and continue as above.

From Harrisburg and West - 78 East to Route 183 South to light at West Leesport Road. Turn right and continue as above OR PA Turnpike Exit 286 (Reading) 222 North to 422 Bypass to 222 North to Route 183 North (Bernville/Strausstown). Turn right and continue as above.

COVID-19 Waiver of Liability applicable for all BCDTC activities

In this waiver of liability, the party who is requesting your signature shall be referred to as Berks County Dog Training Club (BCDTC), Berks County 4H Community Center, instructors, volunteers and their principles.

Due to the outbreak of the novel Coronavirus (COVID-19), BCDTC is doing everything we can to protect you, our members, and our community. To this extent BCDTC will be following the Center of Disease Control (CDC) and the PA Department of Health and Human Services guidance with regard to mask requirements, social distancing practices and sanitation. We ask that all our class and trial participants implement these procedures, including wearing a surgical or cloth mask, social distancing at least 6 feet, and the frequent use of the provided sanitizing products for hands and surfaces.

Prior to attending any BCDTC activity, participants will be asked to consider if they have symptoms that may indicate COVID-19 infection, including:

- A temperature >100.0o F
- Persistent and unusual dry cough
- Fever
- Shortness of Breath (not associated with an underlying medical condition)
- Difficulty Breathing (not associated with an underlying medical condition)
- Chills
- Repeated shaking with chills
- Muscle pain (not attributed to programming activities)
- Headache
- Sore throat
- New loss of taste or smell

Any two of the above symptoms will require immediate return home until a negative COVID-19 test is provided.
